#### **PREFACE**

For the fourth time now the International Conference on Computers for Handicapped Persons is taking place as a successful cooperation between the Austrian Computer Society and 'fortec', the Rehabilitation Engineering Group at the Vienna University of Technology. Again the conference is backed up by several national and international computer societies and related organizations (IFIP, CEPIS, BSC, GI, SI, ACM, IEEE). For me this international cooperation is an indicator for the worldwide importance of and interest in this topic.

The conference has been sponsored by the Austrian Federal Ministry of Environment, Youth and Family Affairs, the Austrian Federal Ministry of Education and the Arts, the Austrian Workers Compensation Board (AUVA), the Österreichische Postsparkasse (PSK), the Federation of Austrian Industrialists, and the Bank Austria.

Following the call for papers more than a hundred experts and research teams have submitted contributions for this conference. For the first time the conference organizers (i.e. the program committee and the organizing committee) decided to split up the contributions into four categories: preconference seminars, conference papers, scientific posters, and short reports that mainly cover ongoing projects and national activities.

After the reviewing process and the subsequent meeting of the program committee, six pre-conference seminars, 79 conference papers, nine scientific posters, and 13 short reports were accepted.
