The International Computer-Assisted Assessment Conference (CAA) has a long tradition in providing a snapshot of the current state of the art of technology-enhanced assessment. In its 17th edition in 2014 the conference for the first time crossed the channel over to mainland Europe. We continued the tradition of establishing the conference as an interdisciplinary event in the intersection between, on the one hand, theory and practice, research and application, computer science, psychometrics and education and, on the other hand, between primary and secondary education, higher education and professional learning. To make the conference more attractive for researchers from different domains we arranged for the first time in the conference's history to publish the proceedings with Springer. The best papers have been selected for a journal indexed in the Social Science Citation Index.

Besides recent trends such as learnig analytics or serious games as new interactive technologies for assessment, contributions from the the field of medical education and technology-enhanced assessment in the health sector were also well represented in the conference program.
