Aims and Scope. Pattern Recognition Letters takes a novel approach to the publication of research work in the field of pattern recognition in its broadest sense. Its main fatures are: concise articles, rapid publication and a broad coverage of the pattern recognition literature.

Letter journals are an important medium of communication in many sciences. The proliferation of literature and the long publication delays have made it nearly impossible for researchers and practitioners to keep up with the new developments within their specialization. *Pattern Recognition Letters* helps to alleviate these problems. The Editorial Board tries to keep publication delays as short as possible.

Pattern Recognition Letters is a refereed journal. Originality, quality and clarity, together with a proper use of the English language are the criteria for choosing the material to be published in the journal.

The subject matter of Pattern Recognition Letters is image processing and pattern recognition in the stricter sense. In those fields, the papers may emphasize theory, methodology, empirical studies or applications. The latter should, however, have a strong methodological component.

The mainstream of letters will focus on new ideas that the author wishes to disseminate rapidly. Central ideas and key results should be presented in a clear and concise manner. Descriptions of complete systems and case studies demonstrating a novel use of existing techniques or containing innovative ideas about data acquisition, analysis and presentation are also acceptable. For such contributions, the official limit of 6 pages may be relaxed.

In line with the newer developments in pattern recognition, the integration of ideas from artificial intelligence with image processing and pattern recognition techniques receives and will continue to receive much attention.

Instructions to Authors *. Papers must be in English and should not exceed 6 printed pages including diagrams, figures, tables, etc. (approx. 13 double-space typed pages).

Papers for publication should be sent in fourfold to one of the Managing Editors. Submission of a paper will be held to imply that it contains original unpublished work and is not being submitted for publication elsewhere. All papers submitted will be refereed. Upon acceptance of an article, the author(s) will be asked to transfer copyright of the article to the publisher. This transfer will ensure the widest possible dissemination of information. Accepted manuscripts will be published within about three months of submission.

Manuscripts should be typewritten on one side of paper only, double-spaced with wide margins. Titles and subtitles should be short. The author should also privide a list identifying all mathematical symbols which are not typed.

The first page of the manuscript should contain the following information: (i) the title; (ii) the name(s) and affiliation(s) of the author(s); (iii) an abstract of not more than 40 words; (iv) keywords and phrases; (v) name and present address of the corresponding author. Important formulae should be numbered consecutively throughout the manuscript as (1), (2), etc. on the righthand side of the pages. Where the derivation of formulae has been abbreviated, it is of great help for referees if the full derivation can be presented on a separate sheet (not to be published).

Footnotes which should be kept to a minimum, should be brief and must be numbered consecutively.

The references should include only the most relevant papers. In the text, references to publications should appear as follows: 'Kanal (1976) reported that...' or 'This problem has been a subject in the literature before (e.g., Kanal, 1976, p. 245)'. The author should make sure that there is a strict one-to-one correspondence between the names (years) in the text and those on the list. At the end of the manuscript, references to a monograph, to a collective work, or to a journal paper should follow, respectively, the following models:

De Mori, R., 1977. Syntactic recognition of speech patterns. In: Fu, K.S. (Ed.), Syntactic Pattern Recognition, Applications. Springer, Berlin.

Originals of professionally drawn figures in black ink on white paper should be provided in a form suitable for photographic reproduction. Care should be taken that lettering and symbols are of comparable size; the captions should be given on a separate sheet. All graphs and diagrams should be referred to as figures and should be numbered consecutively in the text in arabic numerals. Graph paper should be ruled in blue and any grid lines to be shown should be inked in black. Illustrations of insufficient quality which have to be redrawn by the publisher will be charged to the author.

All unessential tables should be eliminated from the manuscript. Tables should have a title in addition to their serial number. Any manuscript which does not conform to the above instructions may be returned for the necessary revision before forwarding to the publisher. There are no page charges and authors will receive 50 offprints free of charge. More offprints may be ordered at cost. Contributors are reminded that, once their contribution has been formally accepted by the Managing Editor, all further correspondence should be sent directly to the Publisher (Elsevier Science B.V. (North-Holland), P.O. Box 103, 1000 AC Amsterdam). As the page proofs will only be corrected at the publisher's office, the presentation of the manuscript should be perfectly clear.
