An Update to CE Society Bylaws

n March 2014, the IEEE Consumer Electronics (CE) Society made two changes to its bylaws. Although small in wording, these two changes addressed our need to enable the Society to be more active with membership and standards development.

The IEEE has been encouraging all Societies to have a vice president (VP) of Membership position written into their bylaws. In 2014, the CE Society Board of Governors (BoG) approved a motion to create a new VP of Membership

position. After passing this motion, a second motion was approved, which detailed the description of this new position in the bylaws. Bylaw 6, section 1.1, describes the VP of Membership.

The second change to the bylaws made a minor revision to the wording of section 4.8.4 to permit the CE Society Standards chair to send project authorization requests (PARs) directly to the IEEE Standards Association without the need for BoG approval. PARs are the means by which standards projects are started within the IEEE. PARs define the scope, purpose, and contact points for the new project.

In the past, PARs first had to be approved by the BoG before they could be sent to the Standards Association. Since the board only meets face to face twice a year, this made it very difficult for the CE Society Standards chair to accomplish his/her work in a timely manner. This change makes the CE Society consistent with how other Societies structure their standards work.
